**Position Summary:** SPLC is seeking a staff attorney with a passion for press freedom and defending the First Amendment rights of student journalists. We are looking for someone who has a love of the law and can think creatively and strategically about how to use the law to protect and promote student press freedom. In addition to staffing the free legal hotline, conducting training and developing website resources, the staff attorney will spearhead follow-up and strategic advocacy efforts around censorship and implementation of New Voices legislation. This follow-up and strategic advocacy work is an expanding area of emphasis for SPLC, which will ensure that state-based student press freedom laws are implemented as intended. The staff attorney will work in close partnership and report to the senior legal counsel and will also work in close cooperation with the communications and advocacy teams.

### Responsibilities:

- Answer legal hotline inquiries in a timely manner, in-person and via email, in coordination with legal team.
- Conduct legal research and write opinion letters where appropriate.
- Spearhead strategic advocacy re: censorship cases in collaboration with advocacy and communications teams.
- Provide legal assistance for New Voices implementation strategy.
- Assist advocacy department with policy proposals, review of pending legislation or regulations which affect student press freedom.
- Testify at legislative hearings.
- Provide training on media law and student press freedom issues, in-person and online.
- Update written materials and develop new legal resources for SPLC website.
- Serve as subject-matter expert and thought leader in student press law and press freedom, including media interviews and speaking engagements.

- Represent SPLC in the community with a high level of enthusiasm, professionalism, and integrity.
- Other duties as assigned.

**Qualifications:**

- At least 3 years of demonstrated experience in media law and First Amendment issues.
- Love of the law and creative thinking about how to use the law to protect and promote student press freedom.
- Superior writing, editing, and verbal communication skills.
- Superior legal research skills.
- Strategic litigation experience (strongly preferred)
- A strong track record as an implementer who thrives on managing a variety of key initiatives concurrently.
- High energy, maturity, and leadership with the ability to serve as a unifying force and to position discussions at both the strategic and tactical levels.
- Sincere commitment to work collaboratively with all constituent groups, including staff, partner organizations, directors, program participants, and other supporters
- Compelling and articulate public speaker.
- Self-starter, able to work independently.
- Mastery of Microsoft Office Suite required.
- Personal qualities of integrity, credibility, and a commitment to and passion for SPLC's mission
- A demonstrated commitment to contributing meaningfully to a workplace where equity and inclusion are core values.
- Ability and willingness to work some nights and weekends
- Ability and willingness to travel nationally approximately 25% of the time, when travel resumes (including overnight and some weekends)
- Active bar license in good standing.
